**Subject: Request for Final Approval of 11 Acid Pond TMDLs**

Dear Mr. Silva:

We respectfully request final TMDL approval for the following 11 assessment units which are listed on our 2004 303(d) list as impaired for aquatic life due to low pH from atmospheric deposition. These assessment units represent beaches located on lakes or ponds which have approved TMDLs for low pH due to atmospheric deposition. As you may recall, 45 "Acid Pond" TMDLs were approved in FY04 and 20 were approved in FY05. These assessment units should have been included with those submittals but were inadvertently omitted. The following table lists the assessment units and the previously approved TMDL which applies.
